Projects Recommended to Pursue Infrastructure Fund Assistance:

Brooke County PSD-Drovers Inn Ext, 12 customers (Tabled application)2023S-2407Kathy Emery described the request, and it is technically feasible.2023S-2407

The Technical Review and Funding Committee recommends the Brooke County PSD pursue a \$517,300 Brooke County ARPA Grant and a \$500,000 IJDC Grant for an estimated project cost of \$1,017,300.

Marie Prezioso moved that the recommendation be approved, Erica Boggess seconded the motion. The motion passed.

East Bank, Town of – Collection Sys Imprvs (Tabled application)2023S-2415Kathy Emery described the request, and it is technically feasible.2023S-2415

The Technical Review and Funding Committee recommends the Midland PSD pursue a \$865,000 DWTRF Principal Forgiveness Loan, a \$365,000 WDA EEGF Grant, and a \$500,000 IJDC Grant for an estimated cost of \$1,730,000.

The Technical Review and Funding Committee recommends the City of Milton pursue a \$1,000,000 CDS Grant, a \$1,000,000 DWTRF Principal Forgiveness Loan, a \$1,000,000 WDA EEGF, a\$1,000,000 Cabell County Commission Grant, a \$300,000 Milton Contribution, and a \$500,000 IJDC Grant for an estimated project cost of \$4,800,000.

Marie Prezioso moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.

Montgomery, City of – Sewer separation (New application/Engineering fee variance) 2023S-2424 Kathy Emery described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Montgomery pursue a \$868,000 CDS Grant, a \$290,018 CDS Match Grant, a \$2,000,000 CWSRF Principal Forgiveness Loan, and a \$1,000,00 IJDC Grant for an estimated project cost of \$4,158,018 and the request for a total engineering fee variance be approved.
