RESOLUTION AUTHORIZING FUNDING FOR FISCAL YEAR 2026 FOR THE CRITICAL NEEDS AND FAILING SYSTEMS SUB ACCOUNT

WHEREAS, the West Virginia Infrastructure and Jobs Development Council (the "Council") was created by Chapter 31, Article 15A of the Code of West Virginia, 1931, as amended (the "Council Act");

WHEREAS, Section 9 of the Council Act created the Infrastructure Fund;

WHEREAS, pursuant to Section 17c of the Council Act, the Water Development Authority (the "Authority") established a Critical Needs and Failing Systems Sub Account (the "Sub Account") within the Infrastructure Fund;

WHEREAS, Section 17c authorizes the Council to instruct the Authority to transfer from the uncommitted loan balances on June 30th of each year up to \$12,000,000 to the Sub Account;

WHEREAS, the Council is authorized to direct the Authority to make loans or grants from the Sub Account when the Council determines that a project will address a critical immediate need by: (1) the continuation of water or wastewater services; (2) addressing water facility or wastewater facility failure due to the age of the facility or facilities; or (3) providing extensions to a water facility or wastewater facility that will add customers with a total project cost of less than \$2,000,000; and

WHEREAS, the Council finds it is in the best interest of the citizens of West Virginia and the promotion of water and sewer projects to authorize the transfer of funds for fiscal year 2026 from the loan balances to the Sub Account.

NOW, THEREFORE, be it resolved by the West Virginia Infrastructure and Jobs Development Council as follows:

- 1) The Council hereby authorizes and instructs the Authority to transfer \$6,000,000 from the loan balances in the Infrastructure Fund to the Sub Account.
- 2) The Authority shall make loans and grants from the Sub Account upon authorization from the Council as required by the Council Act.
 - 3) This Resolution shall be effective immediately upon adoption.

RESOLUTION AUTHORIZING SET ASIDE FOR PRE-APPLICATION FUNDING ASSISTANCE

WHEREAS, the West Virginia Infrastructure and Jobs Development Council (the "Council") was created by Chapter 31, Article 15A of the Code of West Virginia, 1931, as amended (the "Council Act");

WHEREAS, Section 9 of the Council Act created the Infrastructure Fund;

WHEREAS, if the Council determines that pre-application expenses would create a hardship, the Council is authorized to direct the West Virginia Water Development Authority (the "Authority") to provide funding assistance to Governmental Agencies to defray the expenses of the pre-application process;

WHEREAS, the funding assistance is provided from the "loan funds" held in the Infrastructure Fund:

WHEREAS, Senate Bill 584 passed by the Legislature on March 11, 2022, signed by the Governor and in effect from passage increased the amount available for preapplication funding assistance from \$500,000 to \$1,300,000 annually;

WHEREAS, the funding assistance shall be repaid if the proposed project is approved for loan funding but will be converted to a grant if the project is not approved by Council; and

WHEREAS, the Council finds it is in the best interest of the citizens of West Virginia and the promotion of water and sewer projects to authorize the set aside of the preapplication funding assistance for fiscal year 2026 in an aggregate amount not to exceed \$1,300,000.

NOW, THEREFORE, be it resolved by the West Virginia Infrastructure and Jobs Development Council as follows:

- 1) The Council hereby authorizes and instructs the Authority to set aside \$1,300,000 for pre-application funding assistance, for fiscal year 2026, from the loan funds in the Infrastructure Fund.
- 2) The Authority shall make pre-application funding assistance to Governmental Agencies which have been approved by Council.

3) This Resolution shall be effective immediately upon adoption.

RESOLUTION CLEAN WATER STATE REVOLVING FUND

WHEREAS, the West Virginia Infrastructure and Jobs Development Council (the "Infrastructure Council") is a governmental instrumentality organized and existing under the laws of the State of West Virginia (the "State"), particularly Article 15A of Chapter 31 of the Code of West Virginia, 1931, as amended (the "Act") for certain purposes set forth in the Act including encouraging and assisting in a cost effective, coordinated approach to water and wastewater system development as well as the effectuation of job creation; and

WHEREAS, the Infrastructure Council, upon the request of the Department of Environmental Protection, has reviewed the federally sponsored Clean Water State Revolving Fund Program (the "CWSRF") which requires a 2026 fiscal year state match of \$4,946,400 in order to secure \$24,732,000 from the federal government, all of which is to be used for projects as defined in Section 2 of the Act, particularly wastewater system development; and

WHEREAS, the CWSRF has received an additional allotment of \$38,402,000 under the Federal Infrastructure Investment and Jobs Act which requires a match of \$7,680,400, all of which is to be used for projects as defined in Section 2 of the Act, particularly wastewater system development; and

WHEREAS, the Infrastructure Council finds that the leverage of federal dollars through the use of State moneys is an efficient and cost effective means by which to expand and improve the State's infrastructure system; and

WHEREAS, the Infrastructure Council finds that taking part in the CWSRF program is particularly advisable given the ratio of state-to-federal dollar participation; and

NOW THEREFORE, BE IT RESOLVED, by the West Virginia Infrastructure and Jobs Development Council as follows:

RESOLVED: That pursuant to Sections 9, 10 and 11 of the Act, \$4,946,400 and \$7,680,400, respectfully, contained within the Infrastructure Fund for projects be hereby committed to the Department of Environmental Protection for purposes of securing federal dollars and implementing the 2026 CWSRF program.

RESOLUTION DRINKING WATER TREATMENT REVOLVING FUND

WHEREAS, the West Virginia Infrastructure and Jobs Development Council (the "Infrastructure Council") is a governmental instrumentality organized and existing under the laws of the State of West Virginia (the "State"), particularly Article 15A of Chapter 31 of the Code of West Virginia, 1931, as amended (the "Act") for certain purposes set forth in the Act including encouraging and assisting in a cost effective, coordinated approach to water and wastewater system development as well as the effectuation of job creation; and

WHEREAS, the Infrastructure Council, upon the request of the West Virginia Department of Environmental Projection, or any successor thereto ("DEP"), has reviewed the federally sponsored Drinking Water Treatment Revolving Fund Program (the "DWTRF") which requires a 2026 fiscal year state match of \$2,187,000 in order to secure \$10,935,000 from the federal government, all of which is to be used for projects as defined in Section 2 of the Act, particularly water system development; and

WHEREAS, the DWTRF has received an additional allotment of \$24,898,000 under the Federal Infrastructure Investment and Jobs Act which requires a match of \$4,979,600, all of which is to be used for projects as defined in Section 2 of the Act, particularly water system development; and

WHEREAS, the Infrastructure Council finds that the leverage of federal dollars through the use of State moneys is an efficient and cost effective means by which to expand and improve the State's infrastructure system; and

WHEREAS, the Infrastructure Council finds that taking part in the DWTRF program is particularly advisable given the ratio of state-to-federal dollar participation.

NOW THEREFORE, BE IT RESOLVED, by the West Virginia Infrastructure and Jobs Development Council as follows:

RESOLVED: That pursuant to Sections 9, 10 and 11 of the Act, \$2,187,000 and \$4,979,600, respectfully, contained within the Infrastructure Fund for projects be hereby committed to the DEP for purposes of securing federal dollars and implementing the 2026 DWTRF program.
