Bluewell PSD – Sys Imprvs (Tabled application)

2023S-2232

Jason Billups described the request, and it is technically feasible.

The Technical Review and Funding Committee recommends the Bluewell PSD be tabled until the next Technical Review and Funding Committee meeting November 28, 2023.

Kathy Emery moved that the recommendation be approved, Jonathan Fowler seconded the motion. The motion passed.
