Berkeley County PSSD – Woods WWTP Improvements (new application) 2022S-2190 Kathy Emery described the request.

The Technical Review and Funding Committee recommends Berkeley County PSSD – Woods WWTP

The Technical Review and Funding Committee recommends the City of Huntington pursue a \$7,500,000 Huntington ARPA Contribution, a \$1,500,000 CWSRF Debt Forgiveness Loan, a \$500,000 CWSRF Green Stormwater Forgiveness Loan, and a \$500,000 CWSRF Green Energy Forgiveness Loan for an estimated project cost of \$10,000,000.

Kathy Emery moved that the recommendation be approved, John Fowler seconded the motion. The motion passed

Huntington, City of-WWTP Improvements I - (tabled application) 2022S-2245
