The Technical Review and Funding Committee recommends the Boone Co PSD pursue a \$1,000,000 US ACE grant, a \$500,000 WDA EEGF, and a \$500,000 IJDC grant for an estimated project cost of \$2,000,000.

The Technical Review and Funding Committee recommends the Greenbrier PSD 1 pursue a \$1,250,000 CWSRF PF, a \$750,000 WDA EEGF, and a \$500,000 IJDC grant for an estimated project cost of \$2,500,000.

The Technical Review and Funding Committee recommends the City of Parkersburg pursue a \$1,000,000 WV EDA grant, a \$1,273,000 grant from the City/Developer, a \$2,750,000 WV EEGF, and a \$500,000 IJDC grant for an estimated project cost of \$5,523,000.

# Welch, City of-Elim CSO5 (New application)

The Technical Review and Funding Committee recommends the City of Welch pursue a \$500,000 CWSRF loan (0.25%, 40 yrs, 0.25% AF), a \$2,000,000 (not eligible for \$2.5M) CWSRF PF loan, a \$1,500,000 AMLER grant, a \$750,000 CDS grant, a \$544,000 ARC grant, a \$250,000 CDBG-MIT grant, a \$45,000 WV DEP 604b WQMP, a \$53,0000 Welch contribution and a \$500,000 IJDC grant for an estimated project cost of \$5,642,000.

The Technical Review and Funding Committee recommends the Town of Anmoore pursue a \$1,150,000 DWTRF Loan (0.5%, 40 yrs, 0.25% AF), a \$400,000 USDA grant, a \$1,000,000 WDA EEGF, and a \$1,000,000 IJDC Grant for an estimated project cost of \$3,550,000.

# Birch River PSD-Keener Rdg ext, 29 cust (Cost and funding chg)

The Technical Review and Funding Committee recommends the Birch River PSD pursue a \$2,125,000 ARC grant and a \$500,000 IJDC grant for an estimated project cost of \$2,625,000.

The Technical Review and Funding Committee recommends the Town of Ellenboro pursue an \$887,500 DWTRF PF loan and an \$887,500 IJDC grant for an estimated project cost of \$1,775,000.

#### New Haven PSD-Old Gwinn Rd ext, 16 cust (Cost & funding chg)

The Technical Review and Funding Committee recommends the New Haven PSD pursue a \$1,284,677 DWTRF loan (0.25%, 40 yrs, 0.25% AF), \$1,500,000 DWTRF PF loan, a \$1,000,000 CDS grant, a \$200,000 CDS match, a \$40,000 Fayette Co Com grant, a \$107,888 WV American Water Co contribution, and a \$1,000,000 IJDC grant for an estimated project cost of \$5,132,565.

## Thomas, City of-WTP pretreatment (New application)

Jason Billups described the request and it is technically feasible.

The Technical Review and Funding Committee recommends the City of Thomas pursue a \$1,030,000 WDA EEGF and a \$500,000 IJDC grant for an estimated cost of \$1,530,000.

Note: The BPH has listed several concerns in their memo mostly relating to lack of monitoring, reporting, and the utility generally failing to comply with public notification requirements. The City needs to take note of the listed concerns and implement efforts to come into compliance. The City of Thomas and the Town of Davis have both presented projects for WTP improvements. Future consideration should be given to consolidating or interconnecting.
